Heritage Statement

CUBBLE HEAD BARN, BURTERSETT, HAWES DL8 3PL

Assessment of Significance

The building was originally a Stable with fodder store over built in the early part of 19th century as part of what was probably a smallholding relating to Cubble Head. This is a traditional built, originally two storey detached building adjacent to the Cubble Head holiday cottage. It is sat on sloping ground and partly built into the hillside. The building is in two separate parts built at different times.

The lower part, cart shed built against the gable of the original stable with fodder store over.

Architectural/artistic - appearance and aesthetics is of a solid looking building, with little ornament. Disused for many years ago and it lost it's roof.

Assessment of impact and mitigation

The heritage asset will not be affected by the proposals to put a new roof on it, as there are no major changes. Minor alterations, re-opening badly built doorway and windows, this will simplify and unify the building and takes away the negative impact of the current poorly built openings.

The way the project has been devised and designed is one of minimal intervention to the original and external fabric, however it is necessary to safeguard the building by re-roofing and re-use purposes and to retain the agricultural fabric and structure of the original building. The ground floor arrangement is as indicated but designed around retaining the existing window and door openings.

The roof will be ridge and spars construction with an artificial stone slate roof.

CONCLUSION

The conclusion regarding the overall impact of the proposals is of minimal intervention and reduction of negative impact upon this heritage asset. There will be no harm or loss of interest.
