Design & Access Statement.

There has not been a garage or office facility at Ashes farmhouse up until now and under my occupation these are a necessary requirement

The design of this proposal is intended to be sympathetic with the character of the existing Georgian dwelling. The use of local stone detailing, local natural stone roof slates and local natural stone walling will be all made to match the existing on the rear elevation of the farmhouse to which it is juxtaposed. The stone to be used in this proposal will all be strictly local stone that is to be used to suit stone in all respects in character with the stonework of this area. The external stone steps for instance are a typical feature found locally in this area likewise the dark stained wooden joinery.
