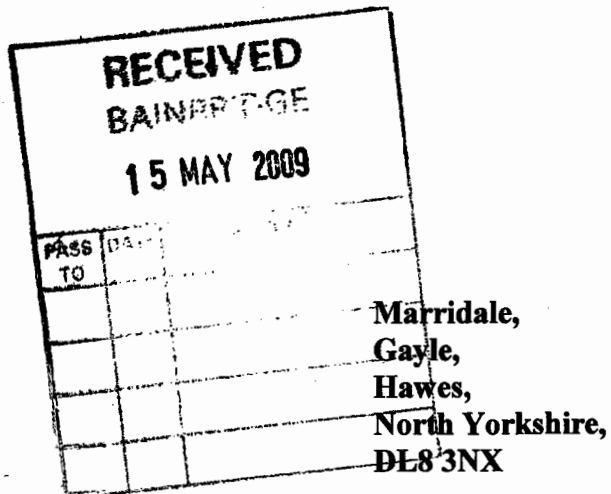

Dear Mrs Lambert,

Reference; Planning application relating to covered way at Marridale, Gayle, Hawes DL8 3NX,

I refer to our meeting on 13th May 2009 regarding the above.

As requested I have prepared a Design and Access Statement.

Design Principle.

The covered way has been designed to form a continuation of the existing garage.

Use.

The covered way is intended to provide a weather proof shelter and allow users to gain access to the existing garage without encountering the worst extremes of the weather.

Scale.

Being the owner of this property it is not in my interests to construct a structure that is not in proportion to the existing building.

The house "Marridale" is a large house and will certainly not be visually intimidated by the proposed covered way.

Landscaping and Appearance.

As can be verified from the supplied plan it is intended to use materials that match the existing stonework of the house and existing workshop. In addition it is also intended to roof the covered way with slates to match the workshop and house.

As the house was constructed approximately 100 years ago it now forms part of the Dales characteristics and if I use materials to match as closely as possible to the existing then it must blend into the area.

Access.

An existing vehicular way already exists.

Although I have touched on this point already I would conclude by again stating that it is not to my advantage to construct something that would be detrimental to my property.
