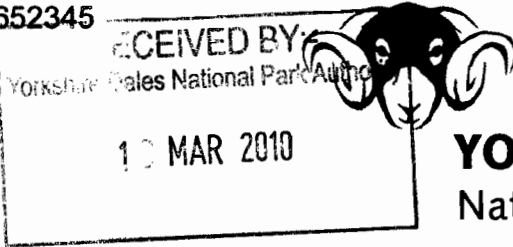

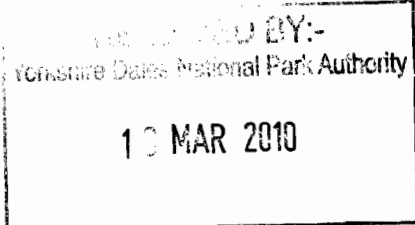

Design and access statement for The Meadows, Fleet Lane, Hetton, BD23 6LR

Since the completion of the new house at the above during the end of summer 09 it has become apparent that the trees etc. planted to the North of the site to protect Benson Cottage have not taken root due to the access road to the field to the rear of the property being hardcore and not conducive to root growth.

My client wishes to extend the rear garden , for his own and Benson Cottages benefit in order that proper screening can be provided to Benson Cottages and also to provide a garden commensurate with the size of the new house.

It will be noticed from the plans attached that the gardens on the east of the main street [Fleet lane] are much deeper than the present garden to The Meadows and that the extension would not look out of place and be in more line with the other gardens than at present and also give greater screening to Benson Cottage as requested in their original objection to the new house. The type and species can be agreed with your landscape section and the adjoining owner. The suggestions seem to give the softness and variation that may be required.
