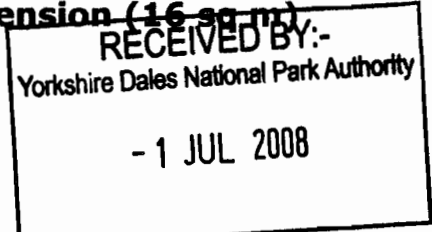

**Planning Application: Single storey rear extension (16 sq m)
to Strands Simonstone**



Design and Access Statement

1. The proposal is to move the outer wall of the single storey kitchen and dining room out by 1.5m.
2. The house is constructed of Yorkshire stone under a stone flag roof and is located in a valley in Fossdale.
3. Design
 - a. Account has been taken of the Yorkshire Dales Local Plan (YDLP) and the Yorkshire Dales Design Guide (YDDG)

i. Appearance and character

*"our **first** and most important concern is the extent to which new building work can affect the appearance and character of what lies around it" (YDLP) and "Where the proposal is to extend an existing building, it is important to avoid visual domination of the existing building" (YDDG)*

The proposed extension involves a 1.5m movement of the outer wall to the north, which retains the character, style and materials of the original building. The addition of <16 sq m of space does not in any way dominate the existing building. The new roof line parallels the main house roof above it.

ii. Material

The works will reuse existing walling, roof and windows materials; additional roofing and walling to the side extension will be matched to these.

iii. Energy efficiency

An opportunity will be taken in these works, to place insulated cavity wall and insulated roof space into the dining room and kitchen, which will reduce the building's carbon footprint.

4. Access

The building is not open to public access. However the proposed extension is located on the ground floor and removes an internal differential level from lounge to dining room, thus facilitating access for people with physical disability.
