Proposed garage and studio room in conjunction with the existing dwelling house

**DESIGN and ACCESS STATEMENT**

---

The existing house approved under decision no. R/27/116A has been built. The later application for a double garage under R/27/116B, approval dated 1 November 2007, has not.

The proposal is to amend and substitute that approval from a double garage by extending out by one metre on the west side and raise the rear wall so that an attic room can be accommodated with an external step access. The room is to provide studio accommodation for the owner and resident of the house in conjunction with residential use.

We considered an alternative appearance symmetrically placing the ridge in the gable and part raising the walls each side but this produced an unbalanced appearance to the south garage door elevation. The proposal gives more of a traditional rural building appearance. The ridge line orientation matches that of the main house roof.

Materials will match those of the house.

Though the west wall is shown against the west boundary of the curtilage marked red the applicant owns the adjoining field marked blue.

The garage floor is level with the ground level and as such accessible to all users.
